Should said dog die from any congenital or genetic defect or disorder during this period, the Seller will replace said dog with another of equal value, provided the buyer, at his/her own cost obtain documentation of the genetic defect or disorder in the form of a necropsy or certified licensed veterinarian report.

Should the the temperament or workability of the dog be unsuitable for the buyer's needs, the Seller will replace said dog with another dog of equal value upon return of the original dog. Said replacement is to be determined by the Seller.

Should said dog die from natural or accidental causes or be injured from natural or accidental causes after the buyer has taken possession of said dog, the buyer remains fully responsible for payment obligations under this contract.

Upon taking possession of said dog by \_\_\_\_\_, the Seller is thereafter released from any and all liability from damages caused by or to said dog excepting the contractual provisions herein stated.

\*Spaying or neutering your dog before one year will nullify this clause.
